Ratification Process and Representative Election

The people you elect will represent your county in the CCR. The should be people with the time and commitment to attend both the CCR meetings and meetings in your county so they understand who they represent and what their desires are. Alternates will attend CCR meetings and be available to function as the representative in their absence from a CCR meeting.

- 1. Call a New State County committee meeting or town hall that is publicly advertised and open to the public.
 - A) Invite a CCR Ambasador to present the charter and answer any questions that may arise in your meeting.
 - B) Create an agenda and attendee sign in list
 - C) Have enough copies of the Charter for attendees
 - D) Prepare a paper ballot for Charter and delegates
- 2. At the meeting:
 - A) Have people you don't know sign a support petition before letting them into the room, that should keep out any potential disruptor's.
 - B) Have an election of a county Chair and Secretary if none currently exist.
 - C) Present an introduction to the Charter with a brief history of our New State movement and what the Charter are intended to accomplish.
 - D) Do a reading of the CCR Charter
 - E) Discuss the charter with a question and answer session
 - F) Vote yes or no on charter
 - G) Nominate perspective candidate(s) for Representative, Alternates 1 & 2 and have them give a short presentation about why they would like to serve.
 - H) Have a vote by show of hands for each nominee.
 - I) Record the vote and report to attendees.
- 3. After meeting:
 - A) Report the ratification and election results to the CCR Founding Committee at mendocino@newstateccr.org
 - B) Maintain records including Agenda, meeting minutes and election results.

Amendment Process

The request for an amendment should be voted on and approved by a majority of your county committee. Submit approved change requests to mendocino@newstateccr.org.

Upon receipt of a request it will be submitted to CCR, at its next meeting, for consideration. If the request is approved by the CCR Founding Committee, new charters will be sent to counties that have ratified.
